Extract of the resolution of the Council

The Tamil Nadu Nurses and Midwives Council resolves to grant **Continuance of Provisional Recognition to Karpaga Vinayaga College of Nursing, Kancheepuram** to conduct the following programmes for the academic year **2020-2021** subject to the following conditions:

1.	B.Sc.,(N)	2020-2021	50
2.	M.Sc.,(N)	2020-2021	25 (Med surg-5, Pae-5, OBG-5,CHN-5, Psy-5)

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2020-2021 and admission must be made only once a year.
3. Every year list of candidates admitted during the year together with their age and qualification to be uploaded in the Council's Institutional Management Software (I.M.S.) for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
4. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.
5. The institution should obtain Affiliation Order from the University for the academic year 2020-2021 before admitting the students and should submit the copy of the same to this Council.

6. **The institution has applied for CMDA/DTCP approval for College of Nursing and Hostel. Need to submit the CMDA/DTCP approval for College of Nursing and Hostel from competent authorities before next academic year.**
7. Failure to maintain the prescribed requirements will result in de-recognition.
8. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, /Indian Nursing Council, New Delhi from time to time.
9. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
10. **Annual Programme fee for Rs.10,000/-B.Sc.,(N)/Rs.15,000/-M.Sc.,(N) must be paid every year by 30th Junethrough online mode in Council website under the link "INSTITUTIONAL MANAGEMENT SYSTEM".**
11. **Council Prescribed Uniform should be adoned by the students and it should be strictly adhered.**
12. All the correspondence should be done by the Principal only.
